The experienced coaches of Northern Lights Junior Volleyball will give your young player a fun, quality introduction to a great game!

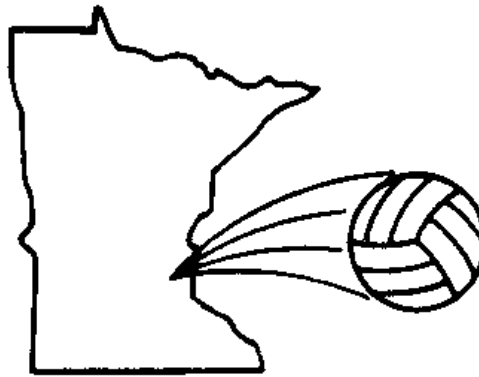
Our goal in this league is to allow your team great competition in a place that allows the athletes to leave their school and compete in a facility solely dedicated to volleyball.
