The facility will be open for the morning sessions 45 min. prior to the first match. The first matches will begin on time. Libero can serve. All matches are the best 2 out of 3. Sets 1 & 2 are to 25 points, set 3 is to 15 points. Third set only played to determine a match winner. We will change sides in the third set at 8 points. All timeouts are 30 seconds, time between games is 2 minutes. Curtain & beam between cts is out of bounds. **10 minute warmups are 2 shared ballhandling, 4 on the court, 4 off. High seed first. Your 4 minutes includes your serving time. 7 minute warmups are 1 shared ballhandling, 3 on the court, 3 off. High seed first. Your 3 minutes includes your serving time.** During your "off" time, your team is not allowed to warmup. You must stand at the end of your bench. No ball handling or warmup of any kind is allowed. When scoreboard horn sounds warmup is over: do not add time to the clock. Please do not use the march and greet protocol prior to the match. Coaches should try to keep both of their courts "in sync". If one court finishes quite early it is acceptable for the warm up time to be extended on the court which is ahead. A court which is ahead of schedule should try to start it's next match no more than 5-10 minutes ahead of the court next to it. Please do not bring balls - Northern Lights will supply Molten volleyballs and carts for warmups and competition.
